- 5. Required if the Account Retrieval hierarchy returns a blank account, otherwise is not required.
- 6. Not required, but must equal the sum of tax amounts from any associated APTX records.
- 7. Not required, but must equal the sum of tax liability amounts from any associated APTX records.
- 8. Not required, but EQ ID, EQ Cost Code and EQ Misc Entry 1 must exist AND the values of EQ Misc Entry 1 and EQ Misc Entry 2 cannot be the same.

- 12. Required if the Property field has a value, otherwise not required.
